By signing this document, you confirm your understanding and agreement to the following terms and conditions:

GENERAL TERMS:

- All freelance photographers and videographers must be assigned by an approved media outlet and must display an official media number. Media vest you will receive after listening the media briefing.
 - Media applicants must be at least 18 years of age at the time of the event.
 - Media representatives must wear the official press vest issued by the organizer. **MANDATORY NUMBER ON THE VEST**
 - Valid life insurance is mandatory. By signing this document, the media representative confirms that they have submitted proof of valid insurance as specified in the official Media Guide from Latvia drift side about FIA/Baltic drift final event side.
 - The event organizer- Latvia Drift, reserves the right to request and access all media content produced during the event.
 - The media accreditation form is considered valid without a physical signature
 - All accredited media personnel must comply with instructions, warnings, and restrictions issued by the event organizers and track officials at all times, also given in official whatss app group.
 - Media representatives must strictly follow the Latvia Drift Media Guide and rules and attend the official Media Briefing if there is such so.

CRITICAL SAFETY POINTS:

1. Wearing a media vest is mandatory while on track. Failure to comply will result in immediate removal from the track area by track officials.
 2. By entering the track area, you accept full responsibility for your own safety and life. Your signature confirms that you accept all associated risks.
 3. The organizer does not guarantee the safety of media personnel within the race track layout. Motorsport is inherently dangerous, and media members entering restricted zones do so at their own risk.

By signing below, you confirm that you:

- Have read and understood all regulations and instructions.
- Have attended the official Media Briefing.
- Agree to all conditions outlined in this document, as well as in prior email communication and the official Latvia drift Media Guide.

- IF YOU ARE IN RACE TRACK, YOU ARE TAKING ALL YOUR LIABILITY FOR YOUR LIFE AND SAFETY, AND WITH YOUR SIGNATURE YOU ARE TAKE ALL RISKS TO YOURSELF.
- The organizer cannot guarantee the safety of the media in the configuration of the race track. The media, when making a decision to enter the track configuration, takes all the risks to himself, related to the fact that motorsport is a dangerous sport

I am fully aware of, appreciate, recognise and accept the risks inherent in my attendance and/or participation in this event, including the possibility of contracting or spreading communicable diseases (including Covid-19 / SARS-CoV-2) and the possibility of incidents resulting in physical and/or mental injury or death which may arise from racing or any associated activities, including motor vehicles (or parts of them) colliding with other motor vehicles or persons or property, the acts (deliberate or otherwise) or omissions of other drivers or any other personnel present at Events, exposure to noise, interaction with or use of high voltage or other equipment at the event and/or in any other way arising from attendance at an event. I appreciate and agree that my attendance at any Cup event shall be at my own sole risk, hazard and responsibility.

Limitation of liability

I undertake that I shall:

Participate in the Cup Events in an individual and neutral capacity and I will not make/display any political, religious and personal statements or comments, notably in violation of the general principle of neutrality promoted by the FIA under the terms of its Statutes

Refrain from any public declaration or comment in any form which may harm, weaken or put into disrepute the goodwill, fame, name and/or image of the Cup and the FIA and/or any of the Associated Bodies;

At all times use my best endeavours to promote and encourage support for the Cup and motor sports generally;

In addition, I confirm that I have read the media booklet and all the information provided in it. I acknowledge that I will follow all instructions and that I will prioritize my health and safety over capturing good photos.

Furthermore, the organizer informs that we reserve the right to immediately revoke any media accreditation, as well as to change safety rules or designated locations during the event, based on our evaluation.
